VISITATION GUIDELINES

EFFECTIVE THURSDAY, NOVEMBER 18, 2021
BASED ON CMS, OHFLAC, AND GOVERNOR'S GUIDELINES

In-Person Visitation:

- 1. All in-person visitation, both indoor and outdoor, have resumed without need for prior scheduling and may occur Monday thru Sunday;
- 2. In order to facilitate uninterrupted resident meals, visitation may occur from 9a to 11a, 1p to 4p, and 6p to 8p;
- 3. All visitors must park in the Rehab Parking Lot on the first row (no parking is allowed in front of the building or in prohibited parking zones);
- 4. All visitors must enter through the Front Door of the facility OR, if difficulty walking or in a wheelchair, come to the Rehab Entrance and ring the doorbell for entry into the building;
- 5. All visitors will be screened upon entry into the facility by our Visitation Coordinator;
- 6. Following screening, each visitor will be escorted to the requested resident room;
- 7. Visitors must remain in the resident's room until the visit is concluded and then exit the building without delay;
- 8. All visitors must exercise proper hand hygiene;
- 9. Regardless of vaccination status, all visitors must wear face masks and physical distance at least six feet between people; and
- **10.** All visitors who have a positive viral test for COVID-19, symptoms of COVID-19, or currently meet the criteria for quarantine, should NOT enter the facility.

Window Visitation:

- 1. Window Visits may be scheduled in order to avoid risk of contracting COVID-19 during facility outbreaks; and
- 2. Call Donna Jones, Director of Activities at 304.636.1391, Ext. 240, to schedule a Window Visit.

Compassionate Care Visitation:

- 1. May occur at any time on any day; and
- 2. For residents in the active dying process or those feeling depressed or anxious.

Outdoor Visitation:

- 1. Weather permitting; and
- 2. Visitation Locations Front Gazabo, Reflections Enclosed Sunporch, Rehab Small Pavilion; and Large Pavilion Behind Facility.

Telephone Visitation:

- 1. May occur at any time on any day; and
- **2.** Call 304.636.1391.

Virtual Visitation:

- 1. May occur at any time on any day;
- **2.** May utilize telephone or iPad through FaceTime or Skype;
- Intermediate (non-Rehab Unit) ResidentsUse Tech1@ercc.biz; and
- 4. Rehab Unit Residents Use Tech2@ercc.biz.

Miscellaneous:

- 1. Regardless of vaccination status, face masks are required for all visitors and are required for all residents, as tolerated; and
- 2. Staff who are not vaccinated but have been granted a medical or religious exemption will continue to be tested two times per week.
